#### Why we need your consent

Meddyg Care uses Individuals' personal data for a number of different reasons. Personal data is any information that identifies the Individual or, in some cases, information that is about the Individual such as an opinion. It includes

the Individual's name, email address, postal address, job role, photographs, CCTV and more sensitive types of information such as medical and health records, care plans, information about the Individual's religious beliefs, origin and race, sexual orientation and political views.

We comply with the law in place in the UK around data protection when we use the Individual's personal data, which is known as "GDPR" (short for the General Data Protection Regulation). It allows us to use the Individual's personal data for a number of reasons without checking with the Individual that it is ok for us to do so. For example, where we can show that we have legitimate reasons to use the Individual's personal data or where we need to use the Individual's personal data to provide services they have requested from us, or to meet a legal obligation placed on us.

However, in some situations we need consent from the Individual to confirm that they are happy for us to use their personal data.

On the basis that the Individual lacks the capacity to consent, we require you to provide that consent on their behalf. We understand that you have authority to provide that consent.
